The first meeting of the County Board of Equalization on Tuesday, July 9, 2019, was called to order by Chair, Thomas C. Davidson, at 1:25 p.m. in the County Commissioners' Meeting Room; Summit County Courthouse, 208 Lincoln Avenue, Breckenridge, Colorado.

- A.** Assessor’s Report of Valuation of Assessment of All Taxable Real Property in Summit County for Tax Year 2019 (Assessor).

Frank Celico presented the Assessor’s Report of Valuation for All Taxable Real Property and noted there were 3,575 real property protests and 2,252 were adjusted.

MOTION: A motion was made by Commissioner Stiegelmeier and seconded by Commissioner Lawrence to accept the Assessor’s Report of Valuation of Assessment of All Taxable Real Property in Summit County for Tax Year 2019, as presented.

MOTION PASSED UNANIMOUSLY BY THE BOARD PRESENT

- B.** Assessor’s Report of Valuation of Assessment of All Taxable Personal Property in Summit County for Tax Year 2019 (Assessor).

Mr. Celico presented the Assessor’s Report of Valuation for All Taxable Personal Property, and noted there were 134 personal property protests and 87 were adjusted. He noted that Personal Property Notices of Determination will be mailed on July 10, the day following this report and the final value after appeals is not yet known*.

2019 Personal Property valuation for Public Utilities has not been distributed by the Property Tax Administrator as of the date of this report.

MOTION: A motion was made by Commissioner Stiegelmeier and seconded by Commissioner Lawrence to accept the Assessor’s Report of Valuation of Assessment of All Taxable Personal Property in Summit County for Tax Year 2019, as presented but is subject to adjustments*.
