1. **CALL TO ORDER**

The Emergency Special Meeting of the Board of County Commissioners on Tuesday, August 7, 2018 was called to order by Vice-Chair, Dan Gibbs, at 11:10 a.m. in the County Commissioners' Meeting Room, Summit County Courthouse, 208 Lincoln Avenue, Breckenridge, Colorado.

II. **ROLL CALL**

III. APPROVAL OF AGENDA

The Agenda was approved, as presented.

IV. **NEW BUSINESS**

Proposed Amendment to Fire Ban Repealing Stage 2 Fire Restrictions.

The Board of County Commissioners' (BOCC) convened an emergency meeting in response to Sheriff Jaime FitzSimons request to remove the Stage 2 fire restrictions and re-enact Stage 1 fire restrictions in unincorporated areas of Summit County. He stated that local, state, and federal cooperators are in agreement that the current data, including weather forecasts and fuel conditions, supports Stage 1 fire restrictions.

Sheriff FitzSimons stated that Scott Fitzwilliams, Forest Supervisor for the White River National Forest, has indicated that the Dillon Ranger District will be adjusting their fire restrictions to Stage 1, repealing Stage 2 restrictions.

Staff recommended approval of the Resolution Repealing Local Fire Hazard Emergency and Stage 2 Fire Ban Restrictions and Re-Enacting Stage 1 Fire Ban Restrictions Banning Open Fires and the Use and Sale of Fireworks in Summit County. Additionally, staff recommended that the administrative closure of the Summit County Shooting Range be lifted.

Commissioner Davidson noted that he agreed the Summit County Shooting Range be reopened.

MOTION: A motion was made by Commissioner Stiegelmeier and seconded by Commissioner Davidson to approve Resolution 2018-46, Repealing Local Fire Hazard Emergency and Stage 2 Fire Ban Restrictions and Re-Enacting Stage 1 Fire Ban Restrictions Banning Open Fires and the Use and Sale of Fireworks in Summit County.
