**I. CALL TO ORDER**

The Meeting of the Board of County Commissioners on Tuesday, September 24, 2019 was called to order by Chair, Thomas C. Davidson, at 1:30 p.m. in the County Commissioners' Meeting Room, Summit County Courthouse, 208 Lincoln Avenue, Breckenridge, Colorado.

**V. PROCLAMATIONS & ANNOUNCEMENTS**

**VII. NEW BUSINESS**

- A. Introduction and first reading of proposed Ordinance No. 19 Adopting Licensing Requirements And Regulating The Sale Of Cigarettes, Tobacco Products And Electronic Smoking Devices (Attorney).**

Amy Wineland gave a brief overview of the ordinance and reviewed the comprehensive approach that has been outlined for reducing youth use of nicotine in Summit County.

Commissioner Lawrence asked how licensing fees would be spent by the County, and whether some of those funds could be utilized to print signage for retailers. Scott Vargo noted that they would be used for enforcement administration. Ms. Wineland stated that a grant has been obtained that can be used for the purpose of signage.

Logan Simson noted differences in brain development in young adults at the ages of 18 and 21. She also noted that allowing 18 year olds to purchase tobacco products makes them more accessible to younger children that attend school with them.

Breanna Roach spoke about the different tobacco products that youth have access to, and ways that the tobacco industry has worked around regulations in the past when one specific product was the target of new laws.

Don Parsons noted his support of the ordinance, as well as his concerns of tobacco on health, and the environmental impacts of nicotine products.

**MOTION: A motion was made by Commissioner Stiegelmeier and seconded by Commissioner Lawrence to approve the introduction and reading of the proposed Ordinance 19, Adopting Licensing Requirements And Regulating The Sale Of Cigarettes, Tobacco Products And Electronic Smoking Devices (Attorney) and ordered that it be published in full and set for a Public Hearing on October 8, 2019.**

**MOTION PASSED UNANIMOUSLY BY THE BOARD PRESENT**

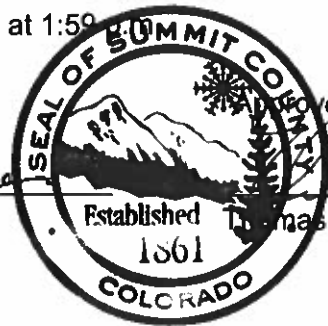
