Non Est. (b.5)	\$20.00
Sheriff's Sale (See Sheriff's Sale Fees Computation Worksheet to determine fees.)	\$200 to be paid in advance. Additional fees are assessed upon the completion or cancellation of each individual case.

Zip Code Based Mileage Fee Schedule

A mileage fee is charged for all papers served in the zip code zone regardless of the number of attempts or actual mileage traveled during a Sheriff's operational period. When serving two or more papers on the same person, or serving papers on different persons at the same time and place in the same action, there will be a zip Code-Based Mileage Fee for the first process and an additional \$10.00 for each subsequent process served (h.5). Mileage based on \$0.54 cents/mile.
